

Connecting Pharmacies to the Australian Immunisation Register (AIR)



Register as a vaccination provider with the AIR

Complete the **Application to register as a vaccination provider form (IM004)** and have your state/territory health department endorse your application.

AIR provider numbers are **not transferable**. Where a business changes ownership and/or business structure, a new AIR provider number must be applied for by the new owner.

Register for PRODA

Provider Digital Access (PRODA) is required to connect to and access the AIR via the AIR site in HPOS.

If your organisation is using pharmacy software, please confirm with your software provider that you need to register for PRODA.

To register an organisation in PRODA, you need to be listed as an Associate or an Authorised Contact for the organisation on the Australian Business Register.

Only one person in the pharmacy needs to do this and they must also register for an individual PRODA account.
